- Has never used the firearm in an illegal fashion; and
- Relinquishes all liability for the firearm once the transaction has been completed.

THE BUYER AGREES THAT THE STATEMENTS LISTED BELOW ARE TRUE AND  
DECLARES THAT HE/SHE:

- Is of legal age to purchase and own a firearm;
- Can obtain, own, ship, and transfer a firearm in accordance with the law;
- Has not been charged and convicted of a crime resulting in a sentence of more than one (1) year in prison;
- Is not an individual who is currently indicted of a serious crime that is punishable by a term in excess of one (1) year in federal or state prison;
- Is not involved in any legal issues regarding a court mandated restraining order for stalking, harassment, or domestic/sexual abuse;
- Has not been charged and convicted of a misdemeanor crime involving domestic violence;
- Is not a fugitive from the law;
- Is not addicted to, nor partake in, any illegal narcotics;
- Has not been formally pronounced mentally unsound and/or committed to a mental facility;
- Is not an illegal or unlawful immigrant who is residing within the United States or a foreign visitor containing a nonimmigrant visa;
- Is a United States citizen and have never relinquished their citizenship;
- Has not been dishonorably discharged from any of the U.S. military branches; and
- Assumes all liability for the firearm once the transaction has been completed.

## 6. MISCELLANEOUS PROVISIONS

The Seller confirms that he/she is the owner of the firearm described in Paragraph 3 with the right to sell it to the Buyer for the purchase price and method listed in Paragraph 4, and certifies that the information provided in this Bill of Sale is true, accurate, and complete to the best of his/her knowledge.

The Buyer and the Seller agree that the property described in Paragraph 3 above shall be sold by the Seller, and purchased by the Buyer, on an “as is” basis and in an “as is” condition, with no express or implied guarantees or warranties regarding the above-described property. The Buyer accepts all liability for the firearm as of the sale date.

This Bill of Sale constitutes the only agreement between the Buyer and the Seller, and all other agreements, whether express or implied, shall have no force and effect except as stated in this agreement.
