- Has not been formally pronounced mentally unsound and/or committed to a mental facility;
- Is not an illegal or unlawful immigrant who is residing within the United States or a foreign visitor containing a nonimmigrant visa;
- Is a United States citizen and have never relinquished their citizenship;
- Has not been dishonorably discharged from any of the U.S. military branches; and
- Assumes all liability for the firearm once the transaction has been completed.

The Buyer and the Seller agree that the property described in Paragraph 3 above shall be sold by the Seller, and purchased by the Buyer, on an "as is" basis and in an "as is" condition, with no express or implied guarantees or warranties regarding the above-described property. The Buyer accepts all liability for the firearm as of the sale date.

This Bill of Sale constitutes the only agreement between the Buyer and the Seller, and all other agreements, whether express or implied, shall have no force and effect except as stated in this agreement.
