So long as a Roommate has paid his or her fair share for the above items, each Roommate has the right to fairly use the above shared items.



- **7. Food.** Each Roommate will purchase their own food and will only eat their own food, and will not eat the food purchased or made by other Roommates. However, the Roommates may agree from time to time to share meals or share food. Each Roommate should designate certain cabinet, counter, fridge, and freezer space for his or her own food items.
- **8. Overnight Guests.** A Roommate may have one overnight guest at a time; however, the guest may not exceed three (3) consecutive nights, unless otherwise agreed by all Roommates. Multiple overnight guests at any one time are subject to approval of all Roommates. The Roommate responsible for the guest(s) must ensure that the guest(s) follows all rules set forth in this Agreement.
- **9. Pets.** Pets are  $\Box$  permitted  $\Box$  not permitted. In any event, all pets must meet the requirements of Landlord. The Roommate who owns the pet is responsible for cleaning up after the pet and all costs associated with the pet.
- 10. Cleaning. Each Roommate agrees to clean up after himself or herself (and their respective guests and pets), including washing dishes reasonably promptly after they are used and not allowing dishes to pile up for prolonged periods of time. Each Roommate is responsible for cleaning his or her own bedroom. The Roommates will equally share the responsibility of cleaning the common areas of the Unit on a regular basis. Any landscape maintenance or other outdoor cleanup duties will also be shared equally by the Roommates.
- 11. Subleasing. If subleasing (also known as "subletting") is permitted under the Lease Agreement, the Roommates agree that (in addition to other terms that the Landlord may require):
- □ All Roommates will have the opportunity to meet the new prospective subtenant and provide feedback as to whether to proceed with the new prospective subtenant.
   □ The Roommate subletting his or her space will have the sole discretion to select the new subtenant.
- 12. Safety; Privacy. The Roommates agree to secure the Unit by appropriately locking it when the Unit is not occupied and to not allow guests or visitors unattended in the Unit. The Roommates agree to respect the privacy of one another, and to not enter another Roommate's bedroom or use another Roommate's personal items unless permitted to do so. The Roommates agree to follow common sense and applicable local and/or state guidelines regarding Covid-19 quarantine and contact tracing requirements and protocol where applicable.
- **12. Disagreements.** If the Roommates disagree on any matter under this Agreement, or any other matter relating to the use or occupancy of the Unit, the Roommates will confer with one another and endeavor to reach a reasonable resolution and/or compromise.

**14. Additional Provisions.** This Agreement may be executed in counterparts, all of which, when taken together, shall constitute one and the same agreement. This Agreement shall be governed by, and construed in accordance with, the laws of the State in which the Unit is located.
