1. **Compliance with Oval Rules and Regulations** (refer to General Handbook)

- 1.1. The student will comply with all the rules and regulations of Oval as may be laid down from time to time with the intent and purpose of ensuring the highest possible academic standard and the best educational results from the whole Student body.
- 1.2. The student is subject to the provisions of the Student Financial Policies and Procedures as enacted in the General Handbook.

2. **Student Liability for damage or loss**

The Student shall be responsible for paying for all damage or loss caused by the Student to any property of Oval or any other person lawfully on the premises of Oval.

Legal Declaration of Indemnity

- 2.1 The Student hereby indemnifies Oval against all claims for loss or damage of whatsoever nature in respect of the student's attendance at the premises of Oval, or any in connection with any activities of Oval in which the Student may participate. Neither Oval nor any official, employee, agent or representative of Oval shall be liable for any loss or damage arising out of the death, bodily injury, loss of health or illness of any Student, howsoever caused.
- 2.2 The Student hereby indemnifies Oval against any claim made against Oval in respect of any damages arising out of the fault of the Student, whenever and howsoever arising.

3. **Termination of Studies**

Registration, once accepted, and the registration fee paid, is binding and cannot be cancelled in any way. In the event of any Student desiring to terminate studies, for any reason whatsoever, this shall not absolve the Student or other Students to this contract from full liability for the payment of fees and any other charges. However, the student may terminate the Contract of Enrolment within 30 days of registration and Oval will levy charges in accordance with the cost of services rendered. The balance paid will be refunded to the student.

4. **Academic Performance**

The Student accepts that his/her enrolment is subject to all the rules and regulations of Oval. In the event of the behavior or academic progress of the Student found to be unacceptable to the Directorate of Oval, the Director, in the exercise of his/her sole discretion, shall have the right to determine and cancel the Student's entitlement to attend Oval. Under no circumstances will the registration fee or other fees paid be refundable.

5. **Student Fees**

- 5.1 In the event of any fees due by the Student being unpaid on the due date, the full outstanding balance of fees shall immediately become due, owing and payable. Interest on all outstanding fees will accrue at the rate of 24% per annum.
- 5.2 A statement of accounting reflecting the amount due by the Account payer and certified as correct by the Bursar of Oval is hereby agreed to be prima facie evidence of the amount so certified and to support an Application for Summary Judgment by Oval against the account payer. Oval reserves the right to cede the collection of fees to a finance house or other institution.
- 5.3 In the event of any proceedings being instituted by Oval against the Student then, by the signature hereto, the account payer consents, in terms of Section 45 (1) of Magistrate's Court Act No 32 of 1994, as amended from time to time, to any proceeding which may be instituted in the Magistrate's Court which has jurisdiction in terms of Section 28 (1) of the Magistrate Court, as so amended, notwithstanding the amount of the claim.
- 5.4 The account payer shall be liable for all legal costs and charges, on an attorney and client scale, incurred by Oval, as well as all tracing costs, collection costs, and any other disbursements which are incurred in recovering monies which may at any time be owed by the account payer to Oval.
- 5.5 The Student acknowledges that the annual fees payable in respect of subsequent years of study will be varied and are not determined on the basis of the applicable fees at the date of first enrolment.
- 5.6 The Student will not receive reports, exam results, certificates or be given access to any other services provided by Oval unless his/her account is up to date and /or paid up in full.
- 5.7 A Student who has failed the academic year shall not receive any reimbursement of the fees due and payable.
- 5.8 Monthly fees must be paid on or before the 7th of each month. Any student enrolling after 31st January will be liable for the deposit plus the first installment.
- 5.9 Reg fee of R650 is non-refundable.

6. **Conditions of Registration**

- 6.1 The Student's failure to attend lectures for whatsoever reason shall in no way entitle him/her to a reduction in fees, nor will it absolve him/her from full liability for the payment of fees and other charges.
- 6.2 No cancellation of this contract shall be of force or effect without written consent there to by an authorized officer of Oval.
- 6.3 The right to attend lectures and write examinations is not transferable.
- 6.4 The Student hereby accepts that Oval shall have the right to vary the course syllabus at any time, without prior notification and without furnishing reasons therefore. Oval shall further have the right to alter timetables and course commencement dates where necessary.
- 6.5 Oval shall have the right at its sole discretion, to cancel tuition in any course or subject initially advertised and offered, on the basis of insufficient demand. Oval further reserves the right to combine classes of a similar academic level and content.
- 6.6 Fees payable to Oval comprise the tuition and registration fees applicable to the year of study the Student has enrolled for and do not include notes, books, stationery or other items.
- 6.7 In the case of any event beyond Oval's control resulting in lectures and/or tuition not being possible, then Oval reserves the right to cease such lectures without affecting refund of fees.
- 6.8 No relaxation, variation or indulgence granted by Oval to other signatories hereto in respect of this agreement shall constitute a waiver of any rights vesting in Oval in terms hereof; and no reliance may be placed by the Student or other signatories hereto or any statement or representation not contained herein.
