for Persons over Sixteen years of age

IMPORTANT: Read Instructions carefully before completing this form.

### NOTES

## HOW TO COMPLETE FORM

 Sections 1, 3, 5, 6, and 11 on this form must be completed by all applicants for new passports.

Section 2 must also be completed by those to whom this section applies.

Section 7must be completed if the applicant's children under 16 are to be included in the passport. The same documentation is required as for separate passports (See note 4).

The form should be clearly written in applicant's own handwriting using BLOCK CAPITALSfor all names.

A new passport is required by a woman on marriage and the requisite fee must be paid.

Children over 16 years of age may not be included in an adult's passport.

Application for a separate passport for a child under 16 should be made on Form "B".

- 2. CERTIFICATION OF APPLICATION. The application must be certified and sponsored in Section 12 by the Passport Officer, any Member of Parliament, Magistrate, Justice of the Peace, Minister of Religion, Police Officer (Gazetted Rank), Bank Manager, Medical Practitioner, Lawyer, School Principal or Senior Civil Servant who has been previously acquainted with the applicant.
- 3. PHOTOGRAPHS. Two copies of a recent photograph of the applicant must be included with the application. These must be taken full face, without hat, on a white background and must not be mounted. The size must not be more than 5 centimetres by 5 centimetres. The person who certifies the application is also required to endorse the reverse side of one copy with the words: "I certify that this is a true photograph of the applicant Mr. (Mrs. or Miss)

and add his/her signature. (Applicants abroad must also submit 2 photos).

All photographs included with an application become the property of the Government of Barbados when it is lodged.

#### 4. DOCUMENTS TO BE PRODUCED

(a) If the applicant was born in Barbados – applicant's Birth Certificate. In cases where the name is not included on Birth Certificate, Baptismal Certificate must be also produced.

For Official Use

(b) Persons born outside Barbados -

It must be noted that any person born outside of Barbados may not be issued with a Barbados Passport unless he is recognized or registered as a Citizen of Barbados by the Ministry.

- Citizenship by descent Letter of recognition as Citizen of Barbados//Certificate of Citizenship.
- (ii) Citizenship by Naturalization or Registration The appropriate Registration Certificate.
- (N.B. Citizens of Barbados who apply for passports in Barbados must produce the Barbados Identification Card <sub>Or</sub> evidence of registration if the card is not available).
  - (c) If children under 16 are to be included in a passport, their Birth Certificate must be produced.
  - (d) All married women must produce their marriage certificates.
  - (e) Children between the ages of 16 and 18 years of age may not be granted passports without the written consent of the parent except where the person under 18 is married.

Section 9 may be completed in reference to (e) above or a separate letter is acceptable. The relationship to the child should be stated in either case (e.g. father, mother, brother, etc.)

- (N.B. Any person claiming legal custody during the lifetime of the parents, must produce the court order committing the child to that person's custody).
  - (f) A change of name other than by marriage or adoption must be substantiated by the production of evidence showing that a bona fide change has been made for all purposes.

The original name is not required in cases of adoption.

**APPLICATION FORM "A"** To avoid delay, answers to all relevant sections should be completed in ink in applicant's own handwriting. There are good reasons for this. Except in the case of physical disability, failure to comply may lead to delay in the issue of passport.
