- 3. Mail or Hand-deliver your signed application and photocopies of your required documents to the appropriate office listed below. Please note that you will not be exempt from tuition payment deadlines. Only approved applications are subject to reimbursement. Decisions made on residency applications that are completed after the fee payment deadline take effect in the next semester. No decision shall be retroactive.
