2015 Decal Renewal Procedure

YOUR "DECAL" IS A RENEWABLE TYPE OF DECAL. IT IS NUMBERED AND ASSIGNED TO YOUR SPECIFIC VEHICLE. YOU ARE ABLE TO RENEW YOUR DECAL ONLINE AS FOLLOWS:

- 1. Go to the Bridge Authority Web-Site, <u>WWW.NCBAABB.COM</u>
- 2. CLICK THE TAB FOR "DECAL ADMINISTRATION."
- 3. Have your Decal #, License Plate, Vehicle and Credit Card Information Ready
- 4. FOLLOW THE INSTRUCTIONS ON RENEWING YOUR DECAL

If you renew you decal through the mail, you MUST attach a copy of your registration. To assure timely processing, please remit a check or money order made payable to the "Nassau County Bridge Authority" to be received no later than January 12 to:

FEE: \$130 - Vehicle Registered to an address in Nassau County

\$175 - Vehicle Registered to an address outside Nassau County

Please be aware that when paying by credit card, there is a nominal service charge of \$3.79 for Resident Decals and \$4.93 for Non-Resident Decals.

The memo line on your check or money order must include the decal number being renewed. The decal number is on the blue stripe of your decal and begins with the letter "A" followed by a five digit code. A \$30 charge is imposed on any returned checks.

AVOID COMPLICATIONS BY RENEWING YOUR DECAL ONLINE!!!

DECAL TRANSFERS:

You must remove and return the original decal to receive a transfer. You may not place the decal on another vehicle or use it in a hand held manner. Any decal that has been altered or placed on a vehicle that is not registered with the Nassau County Bridge Authority will be confiscated and deactivated. The fee for a transfer is \$25. Without the return of the old decal, you will be charged the full cost of a new decal.

Please keep your decal clean. Care must be given to the cleaning of frost and dirt from your decal. Any alterations to the decal will result in it being rejected by the lane scanners. If a decal is damaged by your negligence, a transfer fee will be charged. In order to prevent damage to the decal, do not use an ice scrapper to clean the decal.
