

## Accompanying Form to Duplicate and Transfer a UKC Registered Dog

**Follow these steps to Duplicate a Registration Certificate and Transfer a dog to a new owner:**

- 1) Complete and submit an Application for Duplicate Registration Papers; **and**
- 2) Complete and submit this form; **and**
- 3) Submit Duplicate fee as listed on the back of the Duplicate Application; **and**
- 4) Submit Transfer fee\* for the pedigree the new owner wants to receive:

Transfer and 3 Generation Pedigree.... \$16.00

Transfer and 6 Generation Pedigree.... \$35.00

Transfer and 7 Generation Pedigree (available only if both parents have 'PR' at the start of their name).... \$50.00

\*If this dog is not permanently registered and is now over 1 year of age, an additional fee of \$20.00 applies

This form is to be used only by a dog's current Owner(s) of Record to request a **DUPLICATE** UKC Registration Certificate **AND TRANSFER** of ownership of an individual dog.

This form **must** be submitted with an Application for Duplicate Registration Papers, **must** be completed and signed by the current Owner(s) of Record and **must** have the signature and stamp of a certified public notary.
