Complete the tax payment coupon below if you owe Oregon tax

- Mail your completed coupon and payment by the regular return due date to avoid late payment penalties.
- **Remember:** When you file your return, mark the box "An extension is attached" on the front of the return.

An extension of time to file your return is not an extension of time to pay your tax. If you do not pay 100 percent of your total tax liability by the due date, a 5 percent late payment penalty, plus interest, may be added to your tax due.

How to complete the coupon *(Please use blue or black ink to fill out your coupon and check. Do not use gel pens or red ink.)*

- 1. Oregon Business Identification Number (BIN).** Enter the BIN for the corporation that will file the Oregon tax return. Each corporation doing business in Oregon is assigned a BIN by the department. If this is your first filing year, a BIN will be assigned when your payment is received. If you do not know your BIN, an officer of the corporation may contact us by telephone at 503-378-4988 or e-mail at corp.help.dor.state.or.us.
- 2. Federal Employer Identification Number (FEIN).** Enter the FEIN for the corporation that will file the Oregon tax return.
- 3. Name, Address, and Telephone Number.** When you file your return, check the box on the front of the return if the name or address has changed. **Extension payments must be made in the name of the corporation that will be shown on the tax return when filed.**
- 4. Make check payable to: Oregon Department of Revenue.** To ensure proper credit to your account, write the tax return filer's Oregon BIN and FEIN on your check.
- 5. Detach coupon, keep a copy for your records, and mail with your payment to:**
