### **Additional Shipping and Delivery Instructions**

Orders of more than 24 cartons are palletized and sent by truck. Although your order will arrive on one or more pallets, the driver will offload the cartons and remove the pallets, if asked. When necessary, inside delivery and lift gate service are included. If you are asked to authorize these services, please sign the driver's receipt so we will know the service(s) were performed.

## **Form 8635 Instructions**

- Box 1     Account Number** – This is your TFOP account number. Use this number when making inquiries concerning your account. It cannot be changed.
- Box 2     Organization (Required)** – Verify and/or update the name of your organization.  
(ex: Pebble Hill Library, USPS - Pebble Hill)
- Box 3     Additional Organization Information** – Verify and/or update the name of your department within your organization. (ex: Resources Desk, Postmaster's Office)
- Box 4     Contact Name (Required)** – Verify and/or update the first and last name of the contact person.
- Box 5     Shipping Address (Required)** – Verify and/or update your complete street address or PO Box.  
(ex: 1234 Main St Ste 5, PO Box 123)
- Box 6     Additional Delivery Information** – Verify and/or update your additional delivery information.  
(ex: 1st Fl, Commerce Bldg)
- Box 7     City (Required)** – Verify and/or update your city.
- Box 8     State (Required)** – Verify and/or update your 2-letter state identifier.
- Box 9     Zip Code (Required)** – Verify and/or update your zip code.
- Box 10    Telephone Number** – Verify and/or update your 10-digit telephone number and extension, if applicable. (ex: (555)111-1111 ext 123)
- Box 11    E-mail Address (Required)** – Verify and/or update your e-mail address.
- Box 12    Country Code (Required)** – Select your country's 2-letter identifier.
- Box 13    Remove Account** – Check this box to have your account removed from the program.
- Box 14    Location Question (Required)** – Enter number of locations which will receive products from this order.
- Box 15    Motor Freight Question (Required)** – Answer the question by checking the “Yes” or “No” box.

## **Order Instructions**

Based on your order history, a suggested quantity has been entered in the Order Quantity column. To change the quantity:

- Select the drop down arrow, under Quantity Options, and select the quantity needed (ex: Form 1040 – you may order 0, 50, 250, 1/4 carton which is 750, 1/2 carton which is 1500, a full carton which is 3000, etc.) While viewing the drop down menu, you may need to scroll to see all the available quantity options.
- The Order Quantity will be adjusted based on the amount you have selected
- Products may only be ordered in quantities listed
- Some products may only be available in limited increments
- For the Reference Aids products, enter the quantity needed
