## Certification of Nevada Residency

This certification is used to support a claim that you are a Nevada resident. You must be a resident of Nevada to be eligible for a Driver's License (DL), Driver Authorization Card (DAC) or Identification Card (ID) [NRS 483.250 (7), 483.290 (5)(b), and 483.934]. The definition of "resident" is found in NRS 483.141.

This certification will be accepted as one form of evidence for your principal residence address.

**An original or certified copy of any of the following documents must be submitted with this form. Each document must be dated within the previous 60 days or be the most current available.**

- A property tax record, utility bill, mortgage document or deed, rent receipt, or a lease or rental agreement
- Enrollment records or student identification card from an educational institution located in Nevada reflecting your Nevada residence address
- Motel, hotel, campground or recreational vehicle park receipts showing that you have been residing in Nevada for at least 30 consecutive days
- Original, current certificate of vehicle liability insurance issued by a Nevada-based carrier which reflects your Nevada residence address *(cannot be handwritten)*
- Credit card statement, medical bill, cellular telephone bill, or other statement or request for payment mailed to your Nevada residence address
- A statement from a relief agency or shelter (Form DMV115) that you have no actual residence, but currently receive assistance in Nevada
- Voter registration card issued by the Nevada Secretary of State for the most recent election period which reflects your Nevada residence address
- Documents showing you have a current account at a bank or credit union in Nevada
- Military Leave and Earnings Statement (LES) to evidence Nevada residency when deployed outside of Nevada
- A document showing receipt of public assistance from State of Nevada agency

*This certification must be signed by a second party attesting to Nevada residency if the applicant is not able to produce one of the above required documents with this certification. The second party must reside at the same residential address, accompany the applicant, and present proof of residency in the form of one document listed above.*

**DISCLOSURE STATEMENT:** The Privacy Act as passed by the United States Congress authorizes the use of your Social Security number for the purpose of verifying your identity. This number must be provided and will be used in the administration of driver license laws as required by NRS 483.290. *(This is not required for a DAC.)*

**I hereby certify under penalty of perjury that all statements in this application are true and correct. I agree and understand that any misstatement of material facts may cause cancellation and/or denial of my driver's license or identification card under NRS 483.420 and NRS 483.530, respectively.
