To apply for a Photo ID card you must be at least 15 years of age and reside in Queensland (Qld).

Important information about the delivery of your Photo ID card

If your application is approved, your Photo ID card will be mailed to your postal address within 14 days.

Evidence of Identity (EOI) Requirements

You must give evidence of your identity. You may do so by showing your Qld driver licence, industry authority, marine licence indicator (conditions apply), APA or Photo ID card. All cards must be current or expired by less than two years.

If you are unable to show one of the above you will need to present three other acceptable EOI documents and evidence of your Qld residential address. For a full list of acceptable EOI, evidence of residential address and change of name documents, please refer to the *Evidence of Identity Requirements for Individuals* (form F4362) or visit www.qld.gov.au.
