Certification of Use of Diesel Motor Fuel Purchased in Volume



This certificate is to be used by retail filling stations to purchase diesel product for resale and by diesel motor fuel distributors to purchase highway diesel motor fuel for resale. It may **not** be used by distributors of kero-jet fuel only or retailers of non-highway diesel motor fuel only.

This certificate must be completed by the purchaser and given to the seller, who must keep it for at least three years after the date of the last sale substantiated by this certificate.

Read all statements and certifications carefully before issuing or accepting this certificate.

To the seller: Do not accept this certificate if it is incomplete. Upon receipt of this certificate, properly completed, you are authorized to pass through the prepaid sales tax in lieu of the state and local sales tax. On each sale, you must give the purchaser proper certification of the taxes paid.
