	performance of their official duties, and that I freely, voluntarily, and with such knowledge assume the risk or death, personal injury, or property damage arising from, or in any way connected with the use of weapons, unlawful acts, or forcible resistance by law violators, assault, riot, breach of peace, vehicle accidents, fire, explosion, gas, electrocution, or the escape of radioactive substance while accompanying a member (or members) of the Police Department during the performance of their official duties. 2.
