If the decal is registered under one decal number, show the decal number once and enter serial numbers and HUD label number(s) or HCD insignia number(s).
- 2. Attach the Registered Owner's last issued registration card to a copy of this application.
- 3. Unless the Applicant is the legal owner, attach the copy of the Legal Owner Consent form HCD 480.8 and Junior Lienholder Consent to Move form HCD 481.4, if applicable to the application.
- 4. Mail the completed application with attachments and \$25.00 fee to HCD, P.O. Box 2111, Sacramento, CA 95812-2111.
- 5. Post a copy in a visible location on the front exterior of the manufactured home/mobilehome while the unit is in transit.
- 6. Deliver a copy to the transporter with a copy of the legal owner's consent (HCD 480.8) and junior lienholder's consent (HCD 481.4) forms.
- 7. Retain a copy for your records or use it to advise the Department of the new situs address when the new situs address could not be determined at the time the manufactured home, mobilehome, multi-unit manufactured housing, or floating home was moved from the old situs address.
