  - (The fee should be in the form of a check, cashier's check, or money order made payable to the Texas Department of Motor Vehicles.) **Please do not mail cash.**
- w Photo ID (Government-issued photo ID, such as Texas or other state driver's license, government identification card, U.S. passport, or military identification) of the person signing the Form VTR-34-S.
- w If mailing by **overnight or express mail**, through a mail service which requires a physical address, mail to: Texas Department of Motor Vehicles, Vehicle Titles and Registration Division, 4000 Jackson Ave., Austin, TX 78731.

#### Verifiable Agent of Owner or Lienholder must provide to the department, in addition to the requirements above:

w A verified agent of the owner or lienholder must also provide a letter of signature authority on original letterhead, a business card, or copy of the agent's employee ID.

## If the Form VTR-34-S is signed with a Power of Attorney (POA), the transaction must have, in addition to the requirements above:

- w Photo ID of recorded owner/lienholder signing the POA.
- w Photo ID of individual signing the Form VTR-34-S.
