**FEE CLARIFICATIONS**

**MOBILE HOME UNIT SITE:** When item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites.

**EXPIRATION OF PERMIT**

A permit shall become invalid if the authorized work has not started within 180 days, or if work has been suspended or abandoned for a period of 180 days after work has commenced. A 180 day permit extension may be granted at the cost of \$50. Request for extension must be in writing.  
**CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.**

**PLAN REVIEW**

Plans are required for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Public Act 299 of 1980, as amended, and shall bear that architect's or engineer's signature and seal except:

- ❖ Residential work unless requested by the code official.

**NOTE: WHEN PLANS ARE REQUIRED, PLANS MUST BE SUBMITTED AND REVIEWED BEFORE A PERMIT CAN BE ISSUED.**

**HOMEOWNER AFFIDAVIT**

I hereby certify the electrical work described on this permit application shall be for my own use and occupancy. All work shall be installed in accordance with the Michigan Electrical Code and **shall not be enclosed, covered up, or put into operation** until it has been **inspected and approved**. I understand it is my responsibility to arrange for the required inspections.
