Your intended occupation in Manitoba Your intended occupation in Manitoba is based on your education and work experience. It is the Canadian equivalent to your occupation in your country of residence. Note that in different countries, occupations with similar duties may have different names. To determine your intended occupation use the Working in Manitoba, Canada Tool. Some occupations in Manitoba are regulated and require that you have a licence or certificate issued by a regulatory body before you are able to work in the province. To work in a regulated occupation you must apply to the regulatory body. The regulatory body will assess your qualifications to see if they meet the licensing requirements.
