TERMS OF APPLICATION

- 1. MiED Study Loan is offered to <u>Malaysian citizens</u> studying in local education institutions or overseas.
- 2. For courses in local education institutions, it needs to be approved by Malaysian Qualifications Agency (MQA), whereas all overseas courses require certification from Jabatan Perkhidmatan Awam (JPA). For professional courses, relevant Professional Qualifying Agency in Malaysia who controls and monitor such profession should approve the course.
- 3. Preferences will be given to students who get admission into Kolej Tafe Seremban and AIMST University.
- 4. Students are advised to apply PTPTN loan and provide details of their application to support this loan application.
- 5. MiED will charge interest at the rate of 4% per annum after the duration of the course until the loan is repaid.
- 6. All applicants are required to submit the copy of offer letter from the education institution that confirms the eligibility of the applicant in the course chosen.
- 7. All MiED loan applicants must fulfil the following criteria:
 - a) 4 credits including English and Mathematic at SPM level for Diploma Programmes
 - b) 3 Principal D and above at STPM or equivalent level for Graduate Programmes

- 8. The student only eligible to apply for MiED Loan from 2nd year onwards (MiED won't give priority to student who are perusing foundation, A-Level / studying in the first year).
- 9. Only tuition fees will be considered for MiED Loan.
- 10. The application result and the loan amount is the sole discretion of the MiED Board.
- 11. The payment of loan will be made to the **Education Institution Treasury Office**.
- 12. Loans are <u>approved on yearly basis</u> upon submission of Loan application form and academic results.
- 13. All successful applicants are required to sign a loan agreement with MiED. This agreement is between the loan applicant, two guarantors and MiED. Only one of the guarantors can be a family member. Both guarantor's age must be below 50 years and should not be blacklisted by any financial institution. The repayment of loan will commence 6 months after the duration of the course funded by MiED.
