

How to Download Form-49 on <https://mptax.mp.gov.in>

wef 7th July 2011, MPCTD has made some changes in facility for download Form-49 on MPTAXNET and kept a monthly ceiling for the number of form 49 allowed to be downloaded by dealers.

Complete process for download Form-49 is as described below-

1. Enter your Login Id & Password
2. Select Radio Button Dealer.
3. Select Service Type From Drop Down 'All Activities'.
4. Enter Image from Capcha
5. Click on Login.

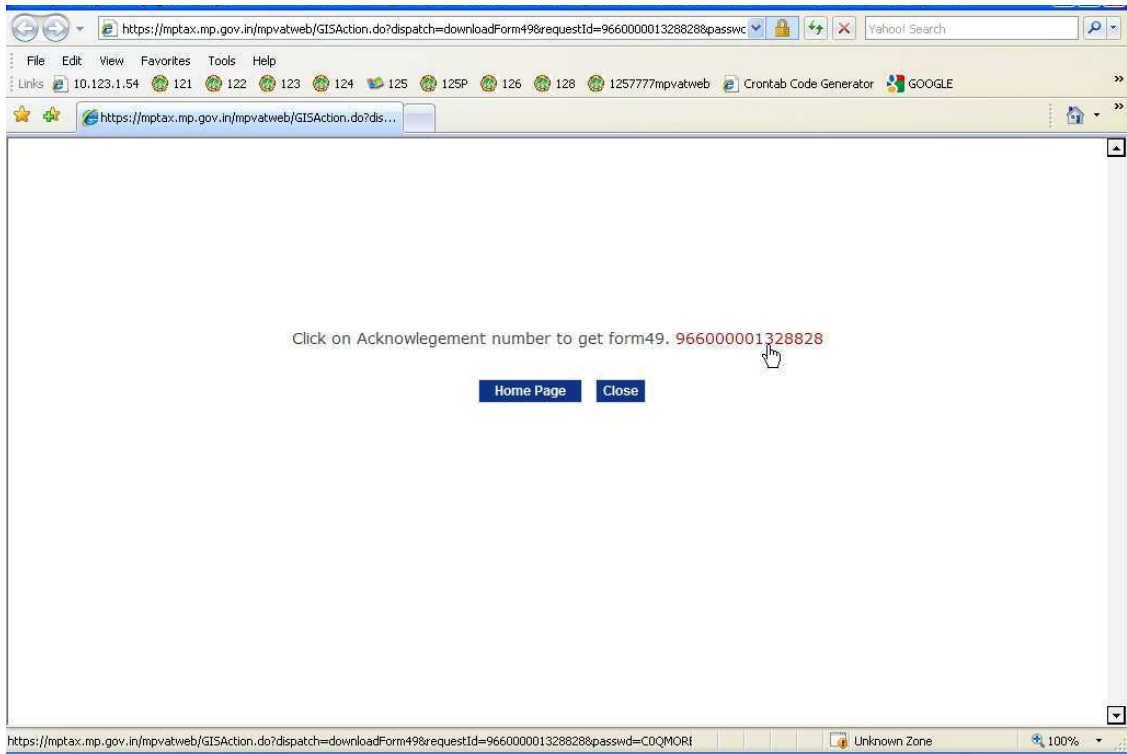
