- 2. I make this affidavit to attest to the above-named Owner's compliance with the requirements of Section 2523(a) of the Rent Stabilization Code (9 NYCRR. § 2523.5(a)) (hereinafter, "RSC") with respect to the tenancy described in the said accompanying Renewal Lease Form, including any person entitled to receive notice pursuant to RSC § 2325.5(b)(l) (hereinafter, "Tenant"), and election to deem the lease for said Tenant renewed pursuant to RSC § 2523.5(c)(2).
- 3. On the form prescribed by the New York State Division of Housing and Community Renewal (hereinafter, "DHCR") for that purpose (DHCR Form RTP-8) or a facsimile of such form approved by the DHCR, dated by the Owner, said Owner notified the Tenant not more than 150 days and not less than 90 days prior to the end of the Tenant's lease term, by mail or personal delivery, of the expiration of the lease term, and offered to renew the lease or rental agreement (hereinafter, "Lease") at the legal regulated rent permitted for such renewal Lease, subject to the requirements of Federal law governing the Section 8 voucher program as described in the required Federal Tenancy Addendum, and otherwise on the same terms and conditions as the expiring Lease.
- **4**. Following such notification, the Owner gave the Tenant a period of 60 days from the date of service of such notice to accept the offer and renew such Lease.
- 5. As indicated by the absence of a Tenant's signature on "Part B" of the accompanying Renewal Lease Form, the Tenant failed to timely renew the Lease, as offered pursuant to RSC § 2523.5(a). Pursuant to RSC § 2523.5(c), the Owner elects to deem the lease renewed upon the same terms and conditions, at the legal regulated rent, together with any guidelines adjustments and changes mandated by governing Federal law that would have been applicable had the offer of a renewal lease been timely accepted.
- 6. The effective date of the "deemed" Renewal Lease, set forth in paragraph 6 of the accompanying Renewal Lease Form, is no less than 90 days after the date the offer of a Renewal Lease was made by the Owner to the Tenant pursuant to RSC § 2523.5(a).
