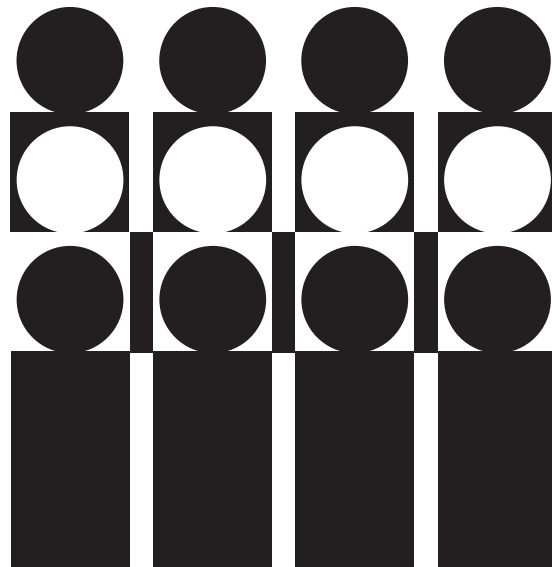


# Oregon Uniform Civil Jury Instructions

## The UCJI Committee has created 19 new instructions and revised eight instructions.

### Highlights on New Instructions:

- UCJI No. 53.02, *Common Law—Private Nuisance*: Provides the elements of a cause of action for private nuisance.
- UCJI Nos. 53A.01–53A.11: Provide the basic instructions necessary for a defamation action, including definitions, elements, and damages.
- UCJI No. 70.20, *Tort Damages—Lost Income—Wage Loss*: Provides a definition of wage loss as one type of lost income included in UCJI No. 70.03.
- UCJI Nos. 80.12–80.17: Provide additional instructions necessary in a landlord-tenant action.

### Highlights on Revised Instructions:

- UCJI No. 5.01, *Precautionary Instructions*: Revised to better address juror use of social media and other technology, and to clarify for jurors the reason for the rules against juror communication with nonjurors.
- UCJI No. 10.03, *Evaluating Witness Testimony*: Revised to include additional bases on which the jury can evaluate witness testimony.
