Florida Building Code BROWARD COUNTY AMENDMENTS Chapter 1 – Administration

106.10.4.4 Upon request of the owner and/or permit holder and on investigation by the Building Official to determine that the work has been abandoned or that the contractor is unable or unwilling to complete the contract a second permit may be issued where there is a change of contractor without the initial permit being revoked or suspended.

106.10.4.4.1 The foregoing will be permitted only when the following stated persons have filed with the Building Official a letter stating the reason for a second permit being required and holding the Building Official harmless from legal involvement. All interested parties shall be notified before action is taken.

- ❖ Where a sub-contractor or specialty contractor is the permit holder the **owner** and **prime contractor** shall both file such hold-harmless letters.
