## **MEMBERSHIP IN THE SHREVEPORT YACHT CLUB**

**Active/Non Resident Members**-Shall have reached the age of twenty-one, shall be entitled to all privileges of the Club, including holding office and voting at all called and general meetings of the Club. The immediate household of the active/non-resident member shall be entitled to the privileges of the Club until they reach the age of twenty-one (age twenty-five if still enrolled as a student in college). Non-resident members must reside more than 50 miles away from the Shreveport Yacht Club.

**Junior Members**-Shall be between the ages of twenty-one and thirty-two. They shall be entitled to enjoy all the privileges of Active Members except that they shall not be eligible to vote or hold office. A Junior Member shall automatically become an Active Member on their thirty-third birthday, upon purchase of one share of stock and paying to the Club the difference between the amount of the initiation fee for a Junior Member and an Active Member with the exception that Junior Members with at least three years standing may attain Active status without paying additional initiation fees. The \$100.00 deposit will be credited towards stock purchase upon conversion to Active Membership status.

**Novice Members**-Shall have reached the age of fourteen and shall not have attained the age of twenty-one and shall be entitled to the privileges of the Club except the right to vote and hold office. The privileges of the Club shall be extended to the immediate members of the Novice Member's family only when accompanied by the Novice Member. A Novice Member shall automatically become a Junior Member upon paying to the Club the difference between the amount of the initiation fee for a Novice Member and a Junior Member in effect at the time he reaches his twenty-first birthday. The change from Novice Membership to Junior Membership shall become effective on January 1<sup>st</sup> following the 21<sup>st</sup> birthday.

**Military Members**-Shall be members of the armed forces on active duty who shall be admitted to membership upon recommendation of two members of the Club and upon approval of the Membership Committee. Military Members shall pay \$100.00 annually as initiation fee; however, total payments are not to exceed the initiation fee for an Active Membership.

## **DEBTS DUE THE CLUB**

All debts due shall be payable immediately upon receipt of Club statement. A 1 ½% service charge (18% interest per year) will be added to all accounts over 30 days old. The cost of postal fees applicable to certified letters concerning delinquent accounts will be charged to the member.

## **JOINT OWNERSHIP OF BOATS**

If a boat is jointly owned by more than one person, each person is required to be a member of the Club.

## **POLICIES**

Club rules do not allow pets on Yacht Club premises.

Glass bottles are a hazard on the grounds. Please purchase canned beverages from the office.

Please inform the office when you bring a boat or trailer in. We will help you find suitable parking and assign SYC stickers.

The Club can be rented for most private parties at extremely reasonable rates. Call the office for details and reservations. The member must be present.
