EMPLOYMENT AND BACKGROUND

In the event of my employment to a position in this Company, I will comply with all rules and regulations of this Company. ARBITRATION AGREEMENT

I further agree and acknowledge that the Company and I will utilize binding arbitration to resolve all disputes that may arise out of the employment context. However, all statutory claim for or related to employment discrimination or harassment must be filed with the federal Equal Employment Opportunity Commission or comparable state or local agency within the time limits set forth by applicable local, state and federal law, prior to being submitted to arbitration or such claims are waived. If the Company or I do not make a written request for arbitration within the limitations period applicable to a claim under applicable federal or state law, the party has waived its right to raise that claim, in any forum, arising out of the issue or dispute. The Company and I agree that, except as provided in this Agreement, any arbitration shall be in accordance with the Federal Arbitration Act. The arbitration shall take place in the county in which Employee worked for Employer, unless such venue is inconvenient to the majority of witnesses expect to be necessary to the case or unless the parties agree to some other locale. The Arbitration fees shall be borne in their entirety by the Employer; except that if I initiate a claim, I will pay a fee equal to the filing fee of the relevant court or jurisdiction. The arbitrator selected shall be selected as follows: The parties shall first attempt to select a neutral arbitrator by mutual agreement. If the parties are unable to select a neutral arbitrator by mutual agreement, the parties will obtain a random list of arbitrators to be prepared jointly by the Company and/or the Applicant. The parties will then alternate striking names from the list, until there remains only one name. This person will act as the arbitrator. The parties to the agreement who seek arbitration and against whom arbitration is sought may within five days of receipt of notice of the nominees from the joint list may jointly select an arbitrator whether or not the arbitrator is among the nominees. The Arbitrator shall apply the substantive law (and the law of remedies, if applicable) of the state in which the arbitration is taking place, or federal law or both, a
