**PLEASE NOTE:**

The court staff is not allowed to give legal advice. Read the instructions carefully and fill out the forms according to the steps outlined in the instructions. If you have questions about a name change that are not answered in the instructions, you should contact an attorney. The Oregon State Bar Lawyer Referral Service can provide names of attorneys in your area. The phone number for lawyer referral is: 1-800-452-7636.

**PLEASE NOTE:**

**You must bring valid photo ID (driver’s license, Oregon photo ID card or passport) with you *each* time you come to the courthouse.** In addition to the above identification, **a certified copy of your birth certificate [as issued by the relevant agency in the state in which you were born] *must* be presented at the time of the name change hearing. Please note: a birth certificate issued by a hospital is insufficient.**

**WHO CAN FILE FOR A NAME CHANGE?**

You must be an Oregon resident and you must file your name change in the county where you reside.

**COST OF NAME CHANGE ?**

The filing fee is \$105.00, the cost of *each* certified copy is \$5.25.

**HOW LONG WILL IT TAKE?**

Depending on the date of your hearing, a name change will take about 4-8 weeks to complete. You will need to come to the courthouse twice, first to file your papers and second to appear at your court hearing. You **cannot** mail your forms to the court. You must post your own notices and sign the declarations at the appropriate time.

**ALL THE FORMS MUST BE COMPLETED IN BLACK OR BLUE INK.**

**NAME CHANGE PROCEDURE:**

1. Fill out the Petition for Name Change (Form 1); Notice of Name Change Hearing, leaving the hearing date blank (Form 2); and the top of the Order to Show Cause and Give Notice of Name Change Hearing (Form 3).
2. **When you are ready to file your petition and set a hearing date, you must appear at Name Change Ex Parte Orientation** which is held in the Probate Department (Room B-7) on Tuesdays and Thursdays (choose one day) from 12:45 p.m. to 1:15 p.m. **If you are not ready to file your petition, a clerk will be available on Tuesdays and Thursdays should you have any procedural questions.** Please note that court staff is not allowed to give you legal advice.

Take forms 1, 2 and 3 to Room B-7 on the basement level of the Washington County Courthouse at 145 N.E. Second Avenue, Hillsboro, Oregon. Bring valid photo ID with you to the courthouse. The clerk will give you a case number and give you a hearing date. Fill in the case number on all of your forms. Fill in the hearing date on the Notice of Name Change Hearing (Form 2). Be sure to note the date and time of your hearing. The clerk will give form 3 to the Judge to sign. Post the Notice (Form 2) on the bulletin board (clerk will inform you of location). Finally, pay the filing fee (\$105.00) at the cashiers.

3. **Before your hearing date:** fill out the Declaration (Form 4). Also fill out the Judgment (Form 5); **do not date or sign.** Be sure to clearly print your present legal name and your new name. Do not use initials as part of your name. Fill out only the top part of the Notice of General Judgment of Name Change (Form 6) and Declaration (Form 7).
4. On the date of your hearing, you must bring forms 4-8 with you to court. Be sure to have a photo ID: (a valid driver's license, an Oregon ID card or a passport) and a certified copy of your birth certificate [issued by the relevant agency in the state in which you were born]. Please note: that a birth certificate issued by a hospital is insufficient. **First take the notice (form 2) off of the bulletin board and go to the courtroom. There will be information on the bulletin board to tell you the number of your courtroom.** In the courtroom, a clerk will verify all documents are in order for the hearing.
5. The court will rule on your request for change of name. The court will keep all of the forms in your permanent file. If someone appears to object, the court will set another time to hear evidence on the objection. If there are objections, the judgment will not be signed, and you will be asked to come back for a second hearing date.
6. If the Judge signs the judgment, you will be required to post the Notice of General Judgment of Name Change (Form 6) on the same bulletin board.
7. Take the Notice of General Judgment of Name Change (Form 6), the Declaration of Posting Notice of General Judgment of Name Change (Form 7) and the Request for Certified Copies (Form 8) to the information counter located near the bulletin board where you posted your notice. A name change clerk will be there to assist you.
8. Fill in the date the Judge signed the judgment on the Notice (Form 6). Sign it with your *present* legal name, not your new name. The clerk will then check your notice and have you post the notice on the bulletin board. It will not be necessary for you to come back to the courthouse to remove your last notice from the bulletin board. The clerks will do this for you after 14 days of posting.
9. Fill out and sign the Declaration of Posting Notice of General Judgment of Name Change (Form 7). **Hand it to the clerk for filing.**
10. Decide how many certified copies of the judgment you will need, fill out Form 8 and pay the fee at the cashiers. **The cashier will keep this form.** The certified copies will be mailed to you within 5 judicial days.
