

**OFFICER'S AFFIDAVIT OF TRANSFER OF MOTOR

The undersigned official who is authorized, pursuant to Sections 12-155 and 12-162 of the Connecticut General Statutes to levy upon the goods and chattels of any person who is delinquent in the payment of personal property taxes to a Connecticut municipality or taxing district, hereby deposes and says as follows:

1. In accordance with a Property Alias Tax Warrant dated \_\_\_\_\_, issued by the Tax Collector of the Town or City of \_\_\_\_\_, I have been commanded to collect a debt for unpaid taxes (and related interest, penalties and fees, as allowed by law) in the name of the following person (hereinafter referred to as "Delinquent Taxpayer"):

2. Pursuant to the said Warrant I have caused to be seized the following motor vehicle owned by the Delinquent Taxpayer:

At the time that the motor vehicle was seized, such motor vehicle was registered and titled in the name of the Delinquent Taxpayer, according to the records of the Department of Motor Vehicles.

3. The Delinquent Taxpayer has been duly notified of the seizure of the said above-described vehicle, and the storage location.

The Delinquent Taxpayer has been notified the he/she may reclaim such vehicle by discharging the tax liability by paying the taxes owed, including interest, fees, costs and charges as allowed by law. Despite such notice and opportunity, the Delinquent Taxpayer has failed to pay the tax liability, or to contest the tax liability or the execution levied thereon in the manner provided by law, or if contested, has failed to secure any ruling, order or judgment in his/her favor.

I have caused an inquiry to be made to the Commissioner of Motor Vehicles concerning the status of title to the above-described vehicle and to determine whether or not there are any security interests that appear on the record of such title and have determined there are no such recorded security interests, or have obtained a letter of lien satisfaction from the lienholder(s) recorded on the certificate of title.
