- The movement of any vehicle or vehicles, not owned by the transporter, constituting the commodity being transported, by a person engaged in the business of furnishing drivers and operators for the purpose of transporting vehicles in transit from one place to another by the driveway or towaway methods.
- The movement of a motor vehicle by any person who is lawfully engaged in the business of transporting or delivering vehicles that are not the person's own and vehicles of a type otherwise required to be registered, by the driveway or towaway methods, from a point of manufacture, assembly or distribution or from the owner of the vehicles to a dealer or sales agent of a manufacturer or to any consignee designated by the shipper or consignor.

NOTE: A driveaway license plate may not be used on a vehicle used or operated on a highway except for the purpose of transporting vehicles in transit. Driveaway license plates may not be used by tow truck operators transporting wrecked, disabled, abandoned, improperly parked, or burned vehicles.

This is to certify that I have and will maintain, during the period of registration, financial responsibility with respect to each motor vehicle that I own, license, or operate on the streets or highways. I also hereby certify that the information given herein is correct and the license plate(s) applied for will be used in accordance with the laws of Missouri. Any false declaration is a crime under 575.060 RSMo. Any false declaration in this application is a violation of the law, and may be punished by fine or imprisonment or both.

DRIVEAWAY LICENSE FEES:

One Year - \$44.50 per driveaway license plate requested plus \$3.50 processing fee, \$48.00 total per driveaway license plate.

Two Year - \$89.00 per driveaway license requested plus \$7.00 processing fee, \$96.00 total per driveaway license plate.

Replacement Driveaway Plate - \$8.50 per plate plus \$3.50 processing fee, \$12.00 total per replacement.

BUSINESS APPLICANTS:

Missouri law requires any person or business entity which transacts business in the state under a name other than their own "true name" to register that business name with the Secretary of State's Office as a Fictitious Name Registration.

INFORMATION REGARDING USE OF DRIVEAWAY LICENSE PLATES:

Driveaway license plates are limited to persons and motor carriers other than motor vehicle dealers and may be used repeatedly by the licensee during the calendar year(s) of issuance. Trailer dealers may purchase one driveaway license plate to demonstrate a motor vehicle acquired by the dealer as a trade-in, if applicable.

Driveaway operations are defined as follows:

1. The movement of a motor vehicle or trailer by any person or motor carrier other than a dealer over any public highway, under its own power singly, or in a fixed combination of two or more vehicles, for the purpose of delivery for sale or for delivery either before or after sale;
2. The movement of any vehicle or vehicles, not owned by the transporter, constituting the commodity being transported, by a person engaged in the business of furnishing drivers and operators for the purpose of transporting vehicles in transit from one place to another by the driveaway or towaway methods; or
3. The movement of a motor vehicle by any person who is lawfully engaged in the business of transporting or delivering vehicles that are not the person's own and vehicles of a type otherwise required to be registered, by the driveaway or towaway methods, from a point of manufacture, assembly or distribution or from the owner of the vehicles to a dealer or sales agent of a manufacturer or to any consignee designated by the shipper or consignor.
