

Form 8050-1 Aircraft Registration Application

Here are a few tips to help you fill out the registration form correctly. Remember, how you fill out this form will determine if you get your registration back in a timely manner or if it will take months of letters back and forth to Oklahoma City. The Aircraft Registry has a specific way they want this done. Do it wrong and they will just send it back. If you do two things wrong they will send you a correction for only the first one they find. When you send it back, if it still has an error they will return it again. They will not tell you that there are more than one errors at a time. So do it right the first time and avoid all the hassle. If you follow the steps below exactly it will go through the first time with no problem. Otherwise it will just be frustrating and time consuming and may lead to your aircraft not being legal to fly. Be sure to have received from the seller a filled out AND signed form 8050-2 "Bill of Sale". Any other "proof of sale" will cause questioning from the Aircraft Registry Branch and could delay your permanent registration certificate.

This is the N-number as it is on the aircraft →

Manufacturer and Model exactly as on the Airworthiness Cert. →

Serial Number exactly as the serial number on the data plate →

Type of registration, if co-owned you must list other owners below

Last name first, then first name & initial. If co-owned then all owners must be listed. Only the first name listed will be able to get the repairman certificate for doing the annuals. →

Address must be a physical address. P.O. Boxes are not acceptable as the only address. If you use a P.O. Box you must list a physical address also or it will be returned causing a delay. →

This area is your certification. Nothing need to be done here unless you are a trust, resident alien or non-citizen. If you are reporting a change of address. Check the box, if not leave it blank. →

VERY IMPORTANT!

You must PRINT your name under your signature, **IN THE SAME BOX!!!!** DO NOT print your name in the second box. The second or third box they are for a second and third owner. If you are the only owner and print your name in the second box the application WILL be returned for that error. Your title is owner and the date must be in xx/xx/xxxx format. If the date is single digit add a zero. The example is wrong →

AC Form 8050-1 (5/03) (0052-00-628-9007)

After filling out the form remove and keep the Pink copy. The Pink copy is your temporary registration that is to be carried in the aircraft until you receive your permanent white postcard registration certificate. The Pink temporary is good for 90 days. Send in the rest of the form, the 8050-2 "Bill of Sale" signed by the seller and \$5.00 to the FAA aircraft registry branch in Oklahoma City.
