Income-Driven Repayment (IDR) Plans can make your monthly payments more affordable relative to your income and family size.

# There are 2 ways to apply:

- 1.) The easiest and quickest way is online.
  - Sign in to StudentLoans.gov using your FAFSA PIN
  - Select Repayment from the left hand side navigation bar
  - Click Complete IBR/Pay As You Earn/ICR Repayment Plan Request
- 2.) Or carefully complete and return the enclosed application with all required documentation

**Note:** If you make federal student loan payments to another company and want to pay those loans under one of these repayment plans, you'll need to send a completed application to them as well.

# The Income-Driven repayment options you'll have on the application:

Whether you apply online or by returning the enclosed form, you can apply for the repayment plans listed below. More information on each of these plans is available on the back of this letter and at MyFedLoan.org/PaymentPlans. If approved, your payment amount will be driven by your income and family size for 12 months at a time (you'll have to recertify each year).

Pay As You Earn

# Things to look out for when completing the form:

- The most common errors involve tax information and income verification, so make sure you include copies of your federal income tax return, the first two pages of 1040/1040A, or the first page of 1040EZ.
- You should supply alternative documentation of income if the Adjusted Gross Income (AGI) on your tax documentation is not
  available or does not reasonably reflect your current financial situation.
  - If you are using alternative documentation of income, your supporting documents, such as pay stubs, must clearly show how often (and how much) you receive in income. You should write this in if it is not already clearly indicated on your documentation.

# Need to change your due date?

When on an IDR plan, you can only change your due date when you first apply or at your annual recertification. If you want to change your due date, please contact us now.

#### OPTIONS FOR FFELP AND DIRECT LOANS

#### REPAYMENT PLAN OPTIONS

If you are unable to make your current scheduled monthly payment, we offer various repayment plans to allow maximum flexibility in the repayment of your education loans. Below are descriptions of the repayment plans that may be available to you based on your loan program. If you would like to change your repayment plan, please call us or visit our website at **www.MyFedLoan.org/PaymentPlans** for additional information on how to submit your request.

Standard (FFELP and Direct): The Standard plan allows you to make a monthly payment that generally remains the same (fixed) throughout the repayment term which cannot exceed 10 years. Consolidation loans may have up to 30 years. However, circumstances or events during repayment may result in changes to the monthly installment amount. Generally, this option is the fastest and most economical method of repayment.

**Graduated (FFELP or Direct):** The Graduated plan allows you to pay a small monthly amount (typically, interest only) during the beginning of the repayment period. Your payment amount will increase, generally every two years, over the repayment term which cannot exceed 10 years. Consolidation loans may have up to 30 years. The amount of interest paid over the life of the loan will be higher with this option than with the Standard Repayment Plan.

25-Year Extended (FFELP or Direct): You may choose a fixed or graduated Extended repayment plan (which is limited to no longer than 25 years). Your monthly payment will be lower; however, the total paid over the life of the loan will be higher than with a 10 year repayment plan (based on interest over time). This repayment plan is only available to you if your loans were first disbursed after October 7, 1998. To utilize this plan on your FFELP Loans, you must have at least \$30,000 in FFELP Loans exclusively. To utilize this plan on your Direct Loans, you must have at least \$30,000 in Direct Loans exclusively.

Pay As You Earn (Direct only)\*: Under Pay As You Earn, your monthly payment amount is based on your (and your spouse's if applicable) Adjusted Gross Income (AGI), family size and state of residence. You must qualify for this plan by being an eligible borrower and providing documentation to prove you have a partial financial hardship. Your payment amount may be adjusted annually, as annual verification of your AGI and family size is required. The maximum repayment period is 20 years. If your loans are not fully repaid after 20 years and you met the repayment requirements, any unpaid amount will be forgiven. Visit our website for more details.

\*Excludes PLUS Loans made to parent borrowers and Consolidation Loans with underlying PLUS Loans made to parent borrowers.

Income-Based (FFELP and Direct)\*: Under Income-Based Repayment (IBR), your monthly payment amount is based on your (and your spouse's if applicable) Adjusted Gross Income (AGI), family size and state of residence. You must qualify for this plan by providing documentation to prove you have a partial financial hardship. Your payment amount may be adjusted annually, as annual verification of your AGI and family size is required. The maximum repayment period is 25 years. If your loans are not fully repaid after 25 years and you met the repayment requirements, any unpaid amount will be forgiven.

\*Excludes PLUS Loans made to parent borrowers and Consolidation Loans with underlying PLUS Loans made to parent borrowers.

Income-Contingent (Direct Only)\*: When you begin paying under this repayment plan, your initial payment amount will be the full amount of interest that accrues each month until we calculate your actual payment amount. Under Income-Contingent Repayment (ICR), your monthly payment amount is based on your (and your spouse's if applicable) Adjusted Gross Income (AGI) and family size. You must provide documentation initially and annually to obtain and maintain this plan. The maximum repayment period is 25 years. If your loans are not fully repaid after 25 years and you met the repayment requirements, any unpaid amount will be forgiven.

\*Available for Stafford Loans, PLUS Loans made to graduate or professional students, and Consolidation Loans.

**Income Sensitive (FFELP Only):** This repayment plan provides a reduced monthly payment amount based on a percentage of your monthly gross income and the monthly interest that accrues on your loans. You must request this plan annually and supply all required documentation.

#### POSTPONING REPAYMENT OPTIONS

If you are unable to make any payments, then a deferment or forbearance might be the right choice to keep your loans from entering default.

**Deferment:** Payments may be deferred if you qualify for one of the deferment conditions listed on your original promissory notes. You must request the deferment and provide any required documentation. You are responsible for the interest that continues to accrue on unsubsidized Stafford Loans, PLUS loans, SLS loans, and the unsubsidized portion of Consolidation Loans during periods of deferment. Any interest that you do not pay during the deferment will be capitalized (added to the principal balance of your loans). Capitalization of interest increases the total cost of your loans. The federal government will pay the accruing interest on subsidized Stafford Loans and the subsidized portion of a Consolidation Loan during periods of deferment.

**Forbearance:** If you do not qualify for a deferment, you may be able to temporarily stop making payments as long as you intend to repay your loans. This option is called forbearance. During a period of forbearance, interest for which you are responsible continues to accrue on all loan types while you are temporarily permitted to stop making payments or to make reduced payments. You must request the forbearance and provide any required documentation. Any interest that you do not pay during the forbearance will be capitalized (added to the principal balance of your loans). Capitalization of interest increases the total cost of your loans.

#### DISCHARGE

A loan discharge is a release of a borrower's or any co-maker's obligation to repay his or her loans, either in whole or in part. Circumstances under which a borrower's or co-maker's loans may be discharged include: bankruptcy, school closure, false certification of your ability to benefit, false certification due to disqualifying status, false certification due to an unauthorized signature/unauthorized payment, false certification as a result of the crime of identity theft, unpaid refund, spouses and parents of September 11, 2001 victims, total and permanent disability, and certain teaching professions. If you feel you may qualify to have your loan discharged under one of these reasons, visit our website at www.MyFedLoan.org for more information or to download an application.

Use this form to (1) request the IBR, Pay As You Earn, or ICR plan for repayment of your Direct Loans or the IBR plan for your FFEL program loan(s), (2) to submit annual documentation for the calculation of the payment amount under the IBR, Pay As You Earn, or ICR plan, or (3) request that your loan holder recalculate your current monthly payment amount because your circumstances have changed. To use the IBR or Pay As You Earn plan, you must meet the eligibility requirements for those plans described in Section 9. Repayment plan calculators are available at studentaid.gov. The calculators are only informational; your loan holder(s) will make the official determination of your eligibility and payment amount based on the information you provide on this form and other required documentation.

You must provide your loan holder(s) with income documentation that will be used to determine your eligibility for the IBR or Pay As You Earn plan and your payment amount for the IBR. Pay As You Earn, or ICR plan, as described in Section 9.

#### SECTION 8: DEFINITIONS

- Capitalization is the addition of unpaid interest to the principal balance of your loan. This will increase the principal balance and the total cost of your loan.
- The William D. Ford Federal Direct Loan (Direct Loan) Program includes Direct Subsidized Loans, Direct Unsubsidized Loans, Direct Unsubsidized Loans, Direct PLUS Loans, and Direct Consolidation Loans.
- Eligible loans for the IBR plan are Direct Loan and FFEL Program loans other than: (1) a loan that is in default, (2) a Direct or Federal PLUS Loan made to a parent borrower, or (3) a Direct or Federal Consolidation Loan that repaid a Direct or Federal PLUS Loan made to a parent borrower. Federal Perkins Loans, HEAL loans or other health education loans, and private education loans are not eligible to be repaid under the IBR plan. To access information on all of your federal student loans, check the National Student Loan Data System at his default.
- Eligible loans for the ICR plan are Direct Loan Program loans other than: (1) a loan that is in default, (2) a Direct PLUS Loan made to a parent borrower, or (3) a Direct PLUS Consolidation Loan (these are Direct Consolidation Loans made based on an application received prior to July 1, 2006 that repaid Direct or Federal PLUS Loans made to a parent borrower). FFEL Program Loans, Federal Perkins Loans, HEAL loans or other health education loans, and private education loans are not eligible to be repaid under the ICR plan. A Direct Consolidation Loan made based on an application received on or after July 1, 2006, including loans that repaid a Direct or Federal PLUS Loan made to a parent borrower, is eligible for the ICR plan. To access information on all of your federal student loans, check the National Student Loan Data System at inside education.
- Eligible loans for the Pay As You Earn plan are Direct Loan Program loans received by a new borrower other than: (1) a loan that is in default, (2) a
  Direct PLUS Loan made to a parent borrower, or (3) a Direct Consolidation Loan-that repaid a Direct or Federal PLUS Loan made to a parent borrower.
   FFEL Program Loans; Federal Perkins-Loans, HEAL loans or other health education loans; and private education loans are not eligible to be repaid under the Pay As You Earn plan. To access information on all of your federal student loans; check the National Student Loan Data System at nsids.ed.gov.
- Family size includes you, your spouse, and your children (including unborn children who will be born during the year for which you certify your family size),
  if the children will receive more than half their support from you. It includes other people only if they live with you now, they receive more than half their....
  support from you now, and they will continue to receive this support from you for the year that you certify your family size. Support includes money; gifts,
  loans, housing, food, clothes, car, medical and dental care, and payment of college costs.
- The Federal Family Education Loan (FFEL) Program includes Federal Stafford Loans (both subsidized and unsubsidized), Federal PLUS Loans, Federal Consolidation Loans, and Federal Supplemental Loans for Students (SLS).
- The holder of your Direct Loans is the U.S. Department of Education (the Department). The holder(s) of your FFEL Program Ioan(s) may be a lender, secondary market, guaranty agency, or the Department. Your Ioan holder(s) may use a servicer to handle billing, payment, repayment options, and other communications on your Ioans. References to "your Ioan holder" on this form mean either your Ioan holder(s) or, if your Ioan holder(s) and servicer are different entities, your servicer.
- The Income-Based Repayment (IBR) plan is a repayment plan with monthly payments that are limited to 15 percent of your discretionary income divided by 12. Discretionary income for this plan is the difference between your adjusted gross income and 150 percent of the poverty guideline amount for your state-of-residence-and family size. To initially qualify for IBR and to continue making income-based payments under this plan, you must have a partial financial hardship (see definition).
- The Income-Contingent Repayment (ICR) plan is a repayment plan with monthly payments that are the lesser of (1) what you would pay on a 12-year standard repayment plan multiplied by an income percentage factor or (2) 20 percent of your discretionary income divided by 12. Discretionary income for this plan is the difference between your adjusted gross income and the poverty guideline amount for your state of residence and family size.
- You are a new borrower for the Pay As You Earn plan if (1) you have no outstanding balance on a Direct Loan or FFEL Program loan as of October 1, 2007 or have no outstanding balance on a Direct Loan or FFEL Program loan when you obtain a new loan on or after October 1, 2007, and (2) you receive a disbursement of a Direct Subsidized Loan, Direct Unsubsidized Loan, or student Direct PLUS Loan on or after October 1, 2011, or you receive a Direct Consolidation Loan based on an application received on or after October 1, 2011. However, you are not considered a new borrower if the Direct Consolidation Loan you receive repays foans that would make you ineligible under part (1) of this definition.
- A partial financial hardship is an eligibility requirement for the IBR and Pay As You Earn plans.
  - For IBR; you have a partial financial hardship when the annual amount due on all of your eligible loans or, if you are married and file a joint federal income tax return, the annual amount due on all of your eligible loans and your spouse's eligible loans, exceeds 15 percent of the difference between your adjusted gross income (AGI), as shown on your most recently filed federal income tax return, and 150 percent of the annual poverty guideline amount for your family size and state of residence. Annual amount of payments due > 15% [AGI (150% x applicable poverty guideline amount)].
  - For Pay As You Earn, you have a partial financial hardship when the annual amount due on all of your eligible loans or, if you are married and file a
    joint Tederal income tax return, the annual amount due on all of your eligible loans and your spouse's eligible loans, exceeds 10 percent of the
    difference between your adjusted gross income (AGI), as shown on your most recently filed federal income tax return, and 150 percent of the annual
    poverty guideline amount for your family size and state of residence. Annual amount of payments due, > 10% [AGI (150% x applicable poverty
    quideline amount)].

#### SECTION 8: DEFINITIONS (CONTINUED)

- For both plans, the annual amount of payments due is calculated based on the greater of (1) the total amount owed on eligible loans at the time those loans initially entered repayment, or (2) the total amount owed on eligible loans at the time you initially request the IBR or Pay As You Earn plan. The annual amount of payments due is calculated using a standard repayment plan with a 10-year repayment period, regardless as to loan type.
- If you are married and file a joint federal income tax return, your AGI includes your spouse's income.
- The Pay As You Earn plan is a repayment plan with monthly payments that are limited to 10 percent of your discretionary income divided by 12.1 Discretionary income for this plan is the difference between your adjusted gross income and 150 percent of the poverty guideline amount for your state of residence and family size. To initially qualify for the Pay As You Earn plan and to continue to make income-based payments under this plan, you must have a partial financial hardship (see definition) and be a new borrower (see definition).
- The poverty guideline amount is the figure for your state and family size from the poverty guidelines published annually by the U.S. Department of Health
  and Human Services (HHS). The HHS poverty guidelines are used for purposes such as determining eligibility for certain federal benefit programs. If you
  are not a resident of a state identified in the poverty guidelines, your poverty guideline amount is the amount used for the 48 contiguous states.
- The standard repayment plan has a fixed monthly amount over a repayment period of up to 10 years for ideas other than Direct or Federal Consolidation Loans, or up to 30 years for Direct and Federal Consolidation Loans.

# SECTION 9: ELIGIBILITY REQUIREMENTS

#### INFORMATION ABOUT THE PAY AS YOU EARN AND IBR PLANS:

- To initially qualify to repay your loan(s) under the IBR or Pay As You Earn plan and to continue to qualify to make payments based on your income, you must have a partial financial hardship (as defined in Section 8). If you are married and file a joint federal income tax return, your loan holder(s) will also take your spouse's income and eligible loans into account when determining whether you have a partial financial hardship.
- For the Pay As You Earn plan, you must be a **new borrower** as defined in Section 8. Although the Pay As You Earn plan is available only for Direct Loan Program loans, your loan holder(s) will take any FFEL Program loans that you have into account when determining whether you have a partial financial hardship except for: (1) a FFEL Program loan that is in default, (2) a Federal PLUS Loan made to a parent borrower, or (3) a Federal Consolidation Loan that repaid a Federal or Direct PLUS Loan made to a parent borrower.
- After entry into the IBR or Pay As You Earn plan, you must annually certify your family size and provide income documentation for determination of whether you continue to have a partial financial hardship. Your loan holder(s) will notify you of the deadline by which you are required to provide this documentation. Your monthly payment amount may be adjusted annually. The new payment amount may be higher or lower, depending on the income documentation and family size information you provide each year.
- You will never pay more per month than you would on the 10-year standard repayment plan, based upon the amount owed on your eligible loans at the time you initially entered the IBR or Pay As You Earn plan. If you do not provide updated income documentation annually, within 10 days of the deadline provided by your loan holder, after requested to do so by your loan holder, your payment amount will be the 10-year standard payment amount calculated at the time that you initially entered the IBR or Pay As You Earn plan and any outstanding interest will be capitalized (added to your principal balance). Under the IBR or Pay As You Earn plan, your monthly payment may be less than the monthly accruing interest. On subsidized loans, you are not required to pay any monthly accrued interest that exceeds your monthly payment amount for a maximum of three consecutive years from the date that you start repaying your loans under the IBR or Pay As You Earn plan. The three-year consecutive period limit does not include any period during which you receive an Economic Hardship Deferment. On unsubsidized loans, all accruing interest is your responsibility.
- If you are determined to no longer have a partial financial hardship or leave the IBR or Pay As You Earn plan, any unpaid interest will be capitalized (added to-your-principal balance).—However, if you are in the Pay As You Earn plan, the amount that is capitalized is limited to 40 percent of the outstanding principal balance on your loans at the time that you entered the Pay As You Earn-plan.
- If you leave the IBR plan, your payment amount will be the standard payment amount calculated based on the outstanding balance of your eligible loans at the time-you-leave the IBR plan and the repayment period remaining for your loans...If you wish to repay your loans under a different repayment plan, you must first make one payment under the standard repayment plan or make a reduced payment under a forbearance agreement while on the standard repayment plan with your loan holder(s):
- Under the IBR plan, if your loan(s) is not repaid in full after you have made the equivalent of 25 years of qualifying monthly payments and at least 25 years have elapsed, any remaining debt will be forgiven. If you receive an Economic Hardship Deferment, any months of Economic Hardship Deferment are considered the equivalent of qualifying payments. Months for which you receive any other type of deferment or months of forbearance are not counted as qualifying payments; and do not count toward the 25-year forgiveness period. Any amount forgiven under the IBR plan may be considered income by the Internal Revenue Service and subject to federal income tax. The Public Service Loan Forgiveness Program allows eligible borrowers to cancel the remaining balance of their Direct Loans after they have served full time at a public service organization for at least 10 years, while making 120 qualifying loan payments, including payments under the IBR plan. For more information, see studentaid.gov/publicservice.
- Under the Pay As You Earn plan, if your loan(s) is not repaid in full after you have made the equivalent of 20 years of qualifying monthly payments and at least 20 years have elapsed, any remaining debt will be forgiven. If you receive an Economic Hardship Deferment, any months of Economic Hardship Deferment are considered the equivalent of qualifying payments. Months for which you receive any other type of deferment or months of forbearance are not counted as qualifying payments, and do not count toward the 20-year forgiveness period. Any amount forgiven under the Pay As You Earn plan may be considered income by the Internal Revenue Service and subject to federal income tax. The Public Service Loan Forgiveness Program allows eligible borrowers to cancel the remaining balance of their Direct Leans after they have served full time at a public service organization for at least 10 years; while making 120 qualifying loan payments, including payments under the Pay As You Earn plan. For more information, see studentaid gov/publicservice.

#### INFORMATION ABOUT THE ICR PLAN:

- All Direct Loan borrowers are eligible to repay their eligible loans on the ICR plan. You are not required to have a partial financial hardship to use the ICR plan. To repay eligible loans under the ICR plan, you must submit documentation of your income. If you are married and file a joint federal tax return, your loan holder will also take your spouse's income into account when calculating your monthly payment amount.
- If you are married, you and your spouse may choose to repay your loans jointly under the ICR plan. If you choose to repay jointly, your loan holder will use your combined income and Direct Loan debt to calculate a joint ICR payment amount, and will then prorate the joint payment amount to determine separate ICR monthly payment amounts for you and your spouse that are proportionate to each individual's share of the combined Direct Loan debt. You and your spouse may select this option under the ICR plan regardless of your federal tax return filing status.

#### SECTION 9: ELIGIBILITY REQUIREMENTS (CONTINUED)

- After entry into the ICR plan, you must annually certify your family size and provide income documentation so that your loan holder can adjust your payment
  amount to reflect more recent income information. Your new payment amount may be higher or lower, depending on the income documentation and family
  size information you provide each year. Your loan holder will notify you when you are required to provide this documentation.
- If you do not provide updated income documentation annually by the deadline provided by your loan holder(s), your payment amount will be calculated based on a 10-year standard repayment plan-using the loan balance at the time you entered repayment under the ICR repayment plan-using the loan balance at the time you entered repayment under the ICR repayment plan.
- Under the ICR plan, your monthly payment may be less than the monthly accruing interest. The accruing interest that is not satisfied by your monthly payment will be capitalized annually. You will receive a notice telling you when the interest will be capitalized, and you will have the opportunity to pay that interest before it is capitalized. While you remain in ICR, the amount of interest that is capitalized will be limited to 10 percent of the outstanding principal balance on your leans at the time that you entered repayment.
- Under the ICR plan, if your loan(s) is not repaid in full after you have made the equivalent of 25 years of qualifying monthly payments and at least 25 years have elapsed, any remaining debt will be forgiven. If you receive an Economic Hardship Deferment, any months of Economic Hardship Deferment are considered the equivalent of qualifying payments. Months for which you receive any other type of deferment or months of forbearance are not counted as qualifying payments, and do not count toward the 25-year forgiveness period. Any amount forgiven under the ICR plan may be considered income by the Internal Revenue Service and subject to federal income tax. The Public Service Loan Forgiveness Program allows eligible borrowers to cancel the remaining balance of their Direct Loans after they have served full time at a public service organization for at least 10 years, while making 120 qualifying loan payments, including payments under the ICR plan.
