- 5. **Limitation**. If a court of competent jurisdiction determines that any covenant contained herein is unreasonable because of its term or territorial scope, or for any other reason, the parties agree that such court may reform the conditions of such covenant so that it is reasonable under the circumstances and that this covenant, as so reformed, shall be enforceable.
- 6. **Applicable Law**. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Washington. Any action for breach or to enforce the terms of this Agreement, including without limitation the covenants and provisions contained in Sections 3 and 4 hereof, may be brought in any state or federal court in county, Washington state, and the parties hereby consent to jurisdiction and venue in such court.
- 7. **Miscellaneous**. The invalidity or unenforceability of any term or provision of this Agreement shall not impair or affect the other provisions hereof, which shall remain in full force and effect.
