Before any recipient of this document relies on it, the recipient should verify the evidence of payment to the undersigned. The undersigned warrants that he or she either has already paid or will use the money received from this progress payment promptly to pay in full all laborers, subcontractors, materialmen, and suppliers for all work, materials or equipment that are the subject of this waiver and release.
